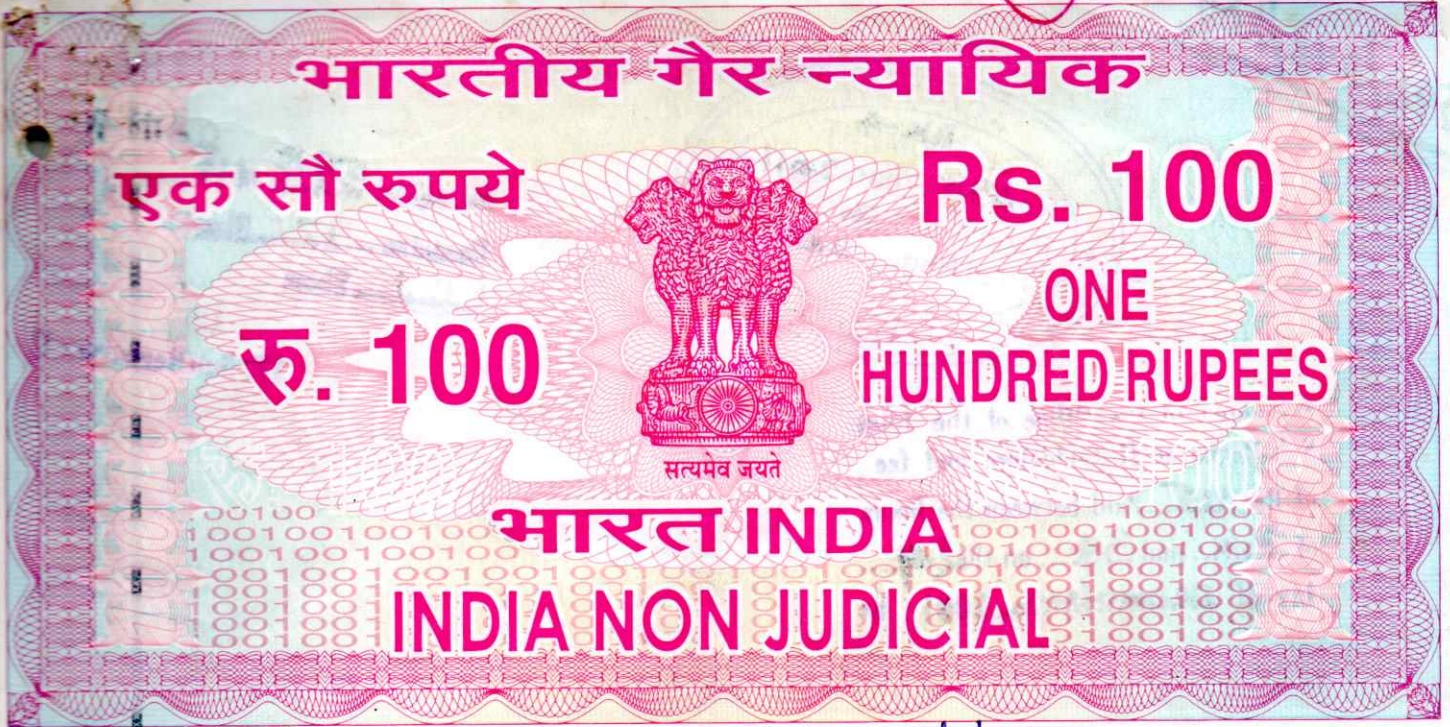

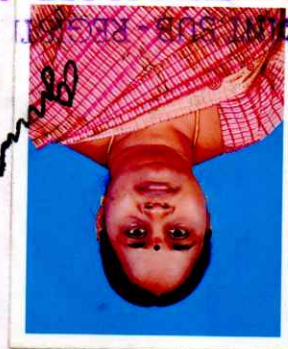

WHEREAS the Author of the above Trust named has been desirous of creating and establishing a public Charitable Trust with the objects of general public utility ensuring for the benefit of the public and WHEREAS with a view to give effect to the said desire has set apart a sum of Rs. 1050/- (Rupees One Thousand Fifty only) for public Charitable purposes and objects of general public utility, and has this day paid into the TRUSTEES the said sum of Rs. 1050 /- (Rupees One Thousand Fifty only).

WHEREAS the aforesaid TRUSTEES have agreed and accepted to be the First Trustees of the Trust, and WHEREAS the Founder of the Trust hereby transfers and pays into the above mentioned TRUSTEES the said sum of Rs. 1050/- (Rupees One Thousand Fifty only) by cash. To have and to hold the same upon trust for the objects described more elaborately herein subject to the powers declared hereunder.

NOW THIS DEED OF TRUST WITNESSETH AND DECLARES AS FOLLOWS:-

1. NAME:

The name of the Trust shall be " **Vee. CHIDAMBARANAR EDUCATIONAL TRUST** " and OFFICE of the trust shall be situated for the present at No: 3/68, Koil Street, Sathankuppam, Cuddalore - 607 004 and such other place or places as the TRUSTEES may decide from time to time.

2. OBJECTS:

The objects of the Trust are:

- (a) To spread knowledge and education amongst all sections of the society irrespective of caste, religion, Sex etc.,
- (b) To establish and/or contribute to, support, or maintain by monetary or otherwise, educational or cultural institutions, colleges, schools, libraries, book-trusts reading rooms, Industrial Training Institutes, Technical Institutions, Polytechnics, workshops cottage and small scale Industries, Research Institutes and other public educational or cultural or charitable institutions or societies.
- (c) To help and promote education and learning. Including Nursery, primary, higher and college education, technical, non-technical Agricultural, Engineering, Medical, Commercial, Financial, Management, Scientific, Philosophic or any subject relating to Arts, subjects, and to establish, run, maintain or finance by adhoc or annual grants or otherwise schools colleges and/or other institutions for all or any of the aforesaid purposes.
